DECORUM ORDER III

AND NOW, this 24th day of June, 2013, after consultation with the Capitol Police and the Administrative Office of Pennsylvania Courts (AOPC), and after pre-trial conference, it is **ORDERED** and **DECREED** as follows:

Seating for the hearing on Petitioners' motions to extend the preliminary injunction and for permanent injunction scheduled to begin on Monday, July 15, 2013, at 1:00 p.m. in Courtroom 3001 on the third floor of the Pennsylvania Judicial Center shall be limited to 108 persons in the gallery on a "first come, first seated" basis. There will be no reserved seating.

The courtroom will be unlocked and available for seating approximately 30 minutes before the opening of court. Capitol Police will begin processing members of the press approximately one hour before the opening of court.

No electronic devices may be used in the courtroom during the hearing, except those used by the Court and by the attorneys representing parties in this suit. No laptop computers or backpacks will be allowed in the courtroom. Cell or smart phones may be carried into the courtroom, but must be turned off at all times.

Conference Room D on the first floor of the Pennsylvania Judicial Center will be available for the use and storage of laptop computers and other electronic devices by members of the press. There will be judiciary personnel supervising the room, but security of things left in the room cannot be guaranteed.

No cameras will be allowed inside the Pennsylvania Judicial Center at any time during the hearing. There will be no recording of the hearing for playback at a later date. A podium will be available outside the Pennsylvania Judicial Center on the plaza for parties that wish to address the media.
