OUR IMPACT

The Public Interest Law Center has built a reputation as an innovative non-profit law firm that develops successful strategies to attack the most pressing civil, social, and economic issues, particularly those deeply entrenched in historic systemic inequities affecting vulnerable communities. Project Areas

Environmental Justice: We represent low-income communities, and particularly communities of color, as they seek to determine the future of their neighborhoods and a healthy environment for themselves and for future generations. In recent years, this work has ranged from helping an urban equestrian organization find a new home for its stables to curbing an overwhelming proliferation of nuisance auto body shops in Southwest Philadelphia. This subject area also encompasses our Garden Justice Legal Initiative, which supports the long-term preservation of community gardens and farms in low-income neighborhoods.

Housing: We seek to increase access to healthy and affordable housing for low-income and disabled tenants. Our strategies include legal support for tenants whose housing is substandard or whose landlords fail to provide disability accommodations; organizing in partnership with local tenants' organization Renters United Philadelphia to advocate for better housing equality; and enforcing existing law by challenging landlords who discriminate against renters who pay their rent using Housing Choice Vouchers.

Public Education: Ensuring the quality of public schools is at the core of our mission to reduce economic inequality and poverty. In 2021 and 2022, we went to trial to challenge Pennsylvania's school funding system, which has left low-wealth school districts severely underfunded across the Commonwealth. In February 2023, this trial resulted in a landmark victory which affirmed Pennsylvania students' constitutional right to a comprehensive and fairly funded education. We also advocate for the rights of students with disabilities, including a recent case which protected students' access to special education services until their 22nd birthday as required by federal law.

Healthcare: We seek to address systemic barriers to healthcare and public health threats. To help end the gun violence epidemic in Pennsylvania's cities, we challenged statewide preemption laws that block local gun safety legislation. Now, we're working to expand Medicaid access to home and community-based services (HCBS) for Pennsylvanians with disabilities, thousands of whom are languishing on wait lists amidst a systemic shortage of services.

Employment: We represent people with criminal records in individual and class action lawsuits related to their right to seek employment. In Pennsylvania, one in three adults has a criminal record; these individuals often face barriers to economic stability because of hiring discrimination that can last for decades following arrest or incarceration. We work to increase employers' compliance with state and local laws prohibiting broad use of criminal background checks, particularly in cases where a prior criminal record has no bearing on the job being applied for.

Voting: We work to ensure that every vote counts in local, state, and national elections. Following a May 2023 election, we successfully sued the Delaware County Board of Elections to ensure that provisional ballots were counted after voters' original mail-in ballots were rejected for technical reasons. As national elections approach in 2024, we remain vigilant to emerging threats to voting rights and are ready to act when voters encounter barriers to the ballot box.
